01. CALL TO ORDER - Town Council President Travis Tschaenn called the Special Joint meeting of the Brownsburg Town Council to order at 6:10 p.m. on April 30, 2020 in the Brownsburg Town Hall, 61 N. Green Street

05. NEW FOR CONSIDERATION –

Jeff Eder presented the Brownsburg Relief Grant Program. Discussion regarding requirements, guidelines, eligibility, and grant amounts ensued. The goal would be able to cut checks every Friday for those who have applied and been approved. Each grant will be up to \$1000. The program will be administered by the Town Manager, Economic Development Director and the Clerk Treasurer. Regular reports will be provided to the Town Council.

A motion to approve this program and related application materials was made by Dennis Dawes. The motion was seconded by Brian Jessen. The motion did not pass by a vote of 0-5. Roll call vote: Jeff Gracey, Brian Jessen, Dennis Dawes, Matt Simpson, Travis Tschaenn – opposed.

A second motion to approve the grant program and related application materials as presented to the council, subject to and conditioned upon, terms being included to recognize OSHA standards and those requirements being applicable to this program and the applicants was made by Jeff Gracey. The motion was seconded by Dennis Dawes. Roll Call vote: Jeff Gracey, Brian Jessen, Matt Simpson, Dennis Dawes, Travis Tschaenn – in favor. Passed 5-0.




11. ADJOURNMENT – A motion to adjourn was made by Dennis Dawes at 6:34 p.m.
